ENTRIES: Use Entry Form B on IDEA website or Omnibus, make checks payable to Les Bois Chapter, IDEA & mail with entry form to Secretary, or do them the easy way on EquestrianEntries.com, where you input your information, verify your cards and either submit entries online with a credit card (fee applies), or print and mail with a check. Entries not accepted without full payment, all signatures, & copies of all memberships or eqverification.org printout. Juniors must provide Medical Release Form. Competitors entered in Opportunity classes are not required to have USDF/USEF member or horse numbers or pay USEF drug fees. Riders may not cross-enter Rated & Opportunity classes. Post entries accepted if space available. Ride Times: Include legible email address, tentative times e-mailed about 1 week prior to show. & posted at www.idahodressageandeventing.org. Check final official ride times posted at show office.

VACCINATION NOTICE: Exhibitors are reminded of USEF's new vaccination policy, effective 12/1/15; see GR845 for details. Download the form from: https://www.usef.org/documents/membership/EquineVaccinationRecord.pdf & bring the completed form, signed by your veterinarian, with you to the competition. If you select an alternative option under the rules, please bring required documentation. Competition Management reserves the right to review vaccination documentation. Non-compliant entries may be quarantined or denied permission to unload, & will not be allowed to compete nor to mingle with other horses. **No refunds will be given if right to compete is denied because the vaccination documentation is missing or incomplete**.

AWARDS: Ribbons to 5th, prizes to 1st provided there are 3 or more per class/division. Classes may be split into divisions if entries warrant. Champion & Reserve for Jr., AA & Open, if 4 or more riders per division at that level. Championship scores will be averaged from 2 highest test scores per level. USDF/Dover Adult Amateur Medal awarded to the highest placed Adult Amateur with 60% or better in the specified class as per USDF rules. See www.usdf.org for requirements for earning the Dover Medal.

SCRATCHES/REFUNDS: 100% refund before closing date; after closing date refunds limited to entrants with vet or doctors excuse less \$25. Secretary must be notified prior to the start of the show & excuse received within 5 days of the close of the show. NO SHOWS forfeit all but drug & qualifying fees. Should the show be cancelled dur to severe weather or other emergency, only drug and qualifying fees will be refunded.

CONCESSIONS: On grounds during show hours.

FARRIER & VETERINARIAN: On call. Names & phone numbers will be posted in the stable areas & the show office.

SMOKING & PETS: For the safety of all concerned, pets & smoking will not be allowed on the show grounds.

STABLING: \$30 per stall per day/partial day or \$75 for Friday-Sunday. Contact Once Upon A Horse directly at jedressage@msn.com to reserve stalls. Send IDEA stabling form & payment to Once Upon A Horse 2880 N Eagle Rd, Eagle, ID 83616. Stalls are semi-permanent Chinook stables, with doors, initial bedding provided, extra bedding available at \$7 per bale. Tack stalls if available at published rates. Facility opens to competitors Friday at noon. Anyone wanting to arrive earlier must get permission; stall for Thursday \$50. Sharps containers will be available for needle disposal in the stabling area(s). Competition Management may fine any individuals including trainers, owners, exhibitors, or their agents up to \$100 for improper disposal of needles or other sharp disposable instruments.

GROUNDS FEE: for non-stabled horses, \$10 per horse per show.

ARENAS: All tests will be ridden in a 20 x 60 Meter arena. All arenas & warm-up areas have sand footing.

DIRECTIONS: From I-84 take the Eagle Road exit north to Once Upon A Horse, 2880 N. Eagle Road & follow the signs in the facility.

ACCOMMODATIONS: Hilton Garden Inn off Eagle Road at 145 E Riverside, Eagle 208-938-9600 within 10 minutes of show grounds. Camping in pasture at Once Upon A Horse, no charge.

Musical Freestyle Sound Checks will be conducted on Friday at 6 pm OR each show day before official show start.

Motorized Vehicle Statement

Minors who do not have a valid driver's license which allows them to operate a motorized vehicle in the state in which they reside will not be permitted to operate a motorized vehicle of any kind including, but not limited to, golf carts, motorcycles, scooters, or farm utility vehicles on the competition grounds of licensed competitions. Minors who have a valid temporary license may operate the above described motorized vehicles as long as they are accompanied by an adult with a valid driver's license. *The parent(s)*, *legal guardian(s)*, *or individual who signs the entry blank as a parent or guardian of a minor operating a motorized vehicle in violation of this rule are solely responsible for any damages, claims, losses or actions resulting from that operation.* Violations of this rule will be cause for sanctions against the parent(s), guardian(s) and/or trainer(s) who are responsible for the child committing the offense. Penalties may include exclusion of the child, parent(s), guardian(s), and/or trainer(s) from the competition grounds for the remainder of the competition and charges being filed against any of the above individuals in accordance with Chapter 6. Wheelchairs and other mobility assistance devices for individuals with disabilities are exempt from this rule.

Membership Statement

Life, senior active and junior active members shall be eligible to participate in all classes at Regular Competitions, Eventing Competitions at the Preliminary Level or above and Combined Driving Competitions at the Advanced Level, Dressage, Reining and Vaulting Competitions and Endurance Rides. A nonmember may participate as a handler, rider, driver, owner, lessee, agent, coach or trainer at Regular Competitions, Eventing Competitions, Dressage Competitions, Reining Competitions and Combined Driving Competitions upon payment of a \$30 Show Pass fee. Participants in the following classes are exempted from the Requirements of this rule: 1) leadline; 2) exhibitions; 3) games and races; 4) classes for 4-H members; 5) walk trot and academy classes (academy classes are classes limited to horses used regularly in a lesson program); 6) USDF introductory level tests, pas de deux and quadrille classes; 7) NRHA Endorsed Reining Competitions. 8) Opportunity classes, 9) citizens of other nations who have proof, in English, of current membership in good standing of their own National Federation, 10) USEA beginner novice division; and 11) assistant handlers in Dressage Sport Horse Breeding classes.
