Entries/ Fees: Checks payable to Common Sense Equestrian; mail with entry to secretary. Post entries accepted on a space available basis; add \$25 fee per entry.

Stabling: On site stabling in panels. \$30/night or \$80/3 nights (Thurs-Sat nights) includes initial bedding. Stabling is a fundraiser for the Sawtooth Pony Club.

Refunds: Before closing date, full refund, less \$25 office fee. After closing date, refund less \$25 office fee **ONLY** if place can be filled from wait list. No shows forfeit all. If clinic or combined test is oversubscribed, priority will be given to those participants riding in both.

Dressage Judge: Kathy McClatchy

Dressage: 40X20m sand. Any USEA, USEF, and USDF tests ridden in a small arena are available for dressage only rides. Please note test choice on entry form.

Jump Course: A mix of cross country and stadium fences on grass.

Awards: Ribbons and prizes for full Event Derby divisions. Scores will be submitted for Event Derby Series Awards.

Times: Tentative times e-mailed prior to show. Check official ride times at office.

Directions: From Highway 75 in Bellevue, turn west on Broadford Rd. After going over the bridge, turn left on Lower Broadford Rd. After about 1 mile, turn right on Townsend Gulch Rd. Farm is first property on the right at 26 Townsend Gulch Rd. Parking is behind the hay barn. **The posted speed limit is 25mph on Lower Broadford Rd and Townsend Gulch Rd. Please obey this speed limit or go SLOWER to keep our neighbors happy!**

Jumping Clinic with Brian Sabo July 7-8, 2017

Brian Sabo, owner of EventingTrainingOnline.com, served as the President of the United States Eventing Association from 2010 - 2013. He first competed in the sport of Eventing in 1962, winning his first Classic Three Day at the Preliminary level in 1968 and then the US Intermediate Championships (Gladstone Trophy) in 1969. Brian's competitive career spanned over 20 years with rides on both East and West coasts at the Advanced level until 1984 when his teaching took precedence. Since then, Brian has been a big part of the Eventing and equestrian worlds, from an extensive clinic calendar to designing and building the 1984 Los Angeles Olympic Eventing show jumping course to coaching Vaulting and Eventing Young Riders programs. Brian is a graduate A Pony Clubber and has served in many volunteer capacities including Woodland Hills Pony Club District Commissioner and serving on the Boards of Governors of the AVA, CDS, USEA, USEF and Woodside Horse Park. Brian is also a highly respected trainer, a faculty member of the USEA Instructors Certification Program, and a Level 4 ICP Instructor. Currently Brian is coaching the USEA Area VI Young Rider team.
