## Clinic Friday and/or Saturday, June 16 and 17, 2017

Jumping and Cross Country Clinic with either Sara Mittleider or Attila Rajnai

**(Opening Date: May 1 – Closing Date: June 1**

*The Idaho Event Derby series* competition consists of a Dressage Test followed by a Jumping Course combining both stadium and cross-country fences. There are approximately 12-22 obstacles, on varied terrain that may include banks, ditches and water. The Idaho Event Derby is an *unrecognized competition, adhering as closely as possible to USEA and US Equestrian Federation Rules* providing a safe and inviting venue for first-time competitors, green horses, as well as seasoned competitors through the Preliminary level. The Idaho Event Derby provides cross training for both horse and rider, regardless of their equestrian discipline.

Class 1	Ground Poles: Dressage test: 2015 USDF Intro A. Jumping Course: ground poles only, 12-15 obstacles. Speed: 200 mpm. Lead horse allowed with prior arrangements with show management.
Class 2	Ground poles jumping phase only (will not be timed or pinned).
Class 3	Cross rails: Dressage: 2015 USDF Intro C. Jumping Course: Maximum Height 18", approx. 12-15 obstacles. Speed: 200 mpm.
Class 4	Cross rails jumping phase only (will not be timed or pinned).
Class 5	Intro Beginner Novice: Dressage: 2014 USEA Beg. Novice A. Jumping Course: Max. height 2'3", approx. 12-15 obstacles. Speed 275 mpm.
Class 6	Intro Beginner Novice jumping phase only (will not be timed or pinned).
Class 7	Beg Novice: Dressage –2014 USEA Beginner Novice A. Jumping Course: Max height 2'7", approx. 12-15 obstacles. Speed: 300 mpm
Class 8	Beginner Novice jumping phase only (will not be timed or pinned).
Class 9	Novice: Dressage: 2014 USEA Novice A. Jumping Course: Max height 2'11", approx. 14-16 obstacles. Water and ditch obstacles. Speed: 325 mpm
Class 10	Novice jumping phase only (will not be timed or pinned.)
Class 11	Training: Dressage: 2014 USEA Training Test A. Jumping Course: Max height 3'3", approx. 16-18 obstacles. Water and ditch obstacles. Speed: 350 mpm.
Class 12	Training jumping phase only (will not be timed or pinned).
Class 13 - Must have 3 entries to run.	Training/Preliminary: Dressage: 2014 USEA Preliminary Test A. Jumping Course: Max height 3'7", approx. 15-20 obstacles. Water & ditch obstacles. Speed: 375 mpm. Stadium at Prelim height.
Class 14	Preliminary jumping phase only (will not be timed or pinned).
Class 15	Dressage Test only - TOC to be identified with entry.
