RELEASE OF LIABILITY
For IDEA-Sanctioned Competitions

Please read carefully:

I understand that horse activities, including shows, are high-risk sports and involve inherently dangerous risks of serious injury or death. I am participating in this horse show at my own risk. In consideration of IDEA's sponsorship and organization of this show, I hereby assume this risk, and further do hereby on behalf of myself, my executors, administrators, heirs, next of kin, successors and assigns: (1) release and hold harmless the organizer, organizing committee, judges, officials, IDEA, it's officers, directors, agents, and volunteers (collectively referred to as "Releasees") from any and all liability for actor or omissions resulting in accidents, damage, death, injury, or illness to myself and to my property, including the horse or horses which I will compete at this horse show; and (2) indemnify the Releasees from any and all liabilities or claims made by other individuals or entities as a result of my actions, or the actions of my horse, during this event.

Warning: Under Idaho law, an equine activity sponsor is not liable for injury to or death of a participant or equine engaged in equine activities resulting from the inherent risks of equine activities. No participant or participant's representative may maintain an action against or recover from an equine activity sponsor or an equine professional for injury to or the death of a participant or equine engaged in an equine activity or resulting from the inherent risks of equine activities. See Equine Immunity Act, I.C. § 6-1801, *et seq.*

This agreement shall be governed by the laws of the State of Idaho. This Release of Liability shall be construed broadly to provide a release and waiver of liability to the maximum extent permissible under law.
